Burke Meisz, of Meisz & Meisz, St. Petersburg, for appellee. PATTERSON, Judge. Wheeling Corporation (Wheeling) appeals a judgment for Donald Corbin in this action for breach of contract. We reverse. On October 14, 1983, appellant approached appellee about purchasing a house which he owned. The parties had several discussions during the next two weeks in regard to the property and the terms and conditions of the sale. Appellee made arrangements to have the house surveyed and showed it to appellant for the purpose of determining what work was necessary to make the house "habitable" for sale. Appellant then entered into an agreement with the seller, which is referred to as the "closing." In the "closing" the parties agreed that appellant would purchase appellee's house for \$75,000.00 and enter into an agreement with the seller for the removal of various items not specified. In addition, appellee agreed to pay a "preexisting back mortgage" and gave appellant until December 31, 1983, to pay the mortgage; if not paid by that date, the \$1,000.00 earnest money would be forfeited. Appellant failed to obtain a mortgage in time, and appellee refused to accept the house unless the mortgage was paid. On January 31, 1984, appellee filed a complaint for rescission of the contract of sale and the "closing." During the trial of the cause, counsel for appellant submitted a motion in limine requesting exclusion of all evidence of the "closing," i.e., the sale, which evidence he considered prejudicial. After ruling that all evidence of the "closing" was admissible,
