The definition of "disabled individual" includes not only those with physical impairments that may prevent an individual from doing their usual form of work, but also those with intellectual and mental impairments. The statute, however, makes no mention of a particular impairment that would qualify an individual for paratransit service. The Department's regulatory analysis has considered a number of specific impairments, including intellectual, sensory, and speech impairments and mental impairments. It has concluded that the definition of a "disabled individual" under the Act is broad enough to include most of the possible impairments that might present a barrier to employment. However, additional regulations that will be addressed in section B to provide further detailed guidance to State planning offices and contractors on the implementation of this rule may make more specific reference to particular impairments that could in some cases be covered under the statute. In particular, we expect to discuss the applicability of the rule to different types of impairments in an amendment to be published in the Federal Register. Any authority granted to a public entity to establish, maintain, or operate a service must be in accordance with the requirements of the ADA. All public entities that contract with providers of paratransit services shall follow the procedures set forth in this rule, particularly the open competition requirement. The Department believes that a public entity that is providing paratransit service must be as inclusive as possible in satisfying the needs of persons with disabilities. This is a critical element in ensuring that people with disabilities may benefit from the various services. The statute also indicates that the factors to be considered under this rule must be capable of being objectively measured. This allows the public entity to be confident that it is being objective in evaluating a provider for the service.

This section provides three examples of the application of the requirements of this section and Sec. 206.3 to a common situation: where a train has a “mini-high” platform at one or more stops. Section 206.3(a) notes that “mini-high” platforms exist at certain stations. This term is intended to refer to the platforms built at stations serving less than 5,000 passengers per day, which are usually found on low-speed passenger rail lines and at some intermediate-speed passenger rail lines. This refers to units between “mini-high” and “full-high” platforms in terms of foot print. A full high platform is a platform whose greater foot print is larger than that of a normal-length platform and smaller than a double-wide platform. A normal-length platform has the same foot print as a full-high platform, but with a length no longer than 20 feet. A double-wide platform has a length of at least 20 feet and a foot print that is typically larger than a normal-length platform and smaller than a full-high platform. When a station is served by a “mini-high” platform, the rules of this section apply. A “mini-high” platform is defined in this section as one with a maximum foot print that is no more than 18 inches wider and no more than 20 feet in length than a normal-length platform. The “leg” of a mini-high platform has a foot print that is no more than 8 inches wider and no more than 10 feet in length than a normal-length platform. The “sill” or cross section of the mini-high platform has a foot print that is no more than 6 inches wider than the foot print of a normal-length platform. 5ec8ef588b
